United Republic of Tanzania*: draft resolution

Economic and technical cooperation among developing countries

The General Assembly,

Reaffirming its resolutions 33/134 of 19 December 1978, in which it endorsed the Buenos Aires Plan of Action for Promoting and Implementing Technical Cooperation among Developing Countries, 46/159 of 19 December 1991 on technical cooperation among developing countries, 49/96 of 19 December 1994 on a United Nations conference on South-South cooperation and 50/119 of 20 December 1995 on economic and technical cooperation among developing countries and a United Nations conference on South-South cooperation, as well as other relevant resolutions of the General Assembly and the Economic and Social Council on economic and technical cooperation among developing countries,

Reaffirming further that South-South cooperation constitutes an important element of international cooperation for development and is an essential basis for national and collective self-reliance as well as a means of ensuring the effective participation of the developing countries in the world economy and that it is not a substitute for, but rather complementary to, North-South cooperation,

Recognizing the fact that developing countries have the primary responsibility for promoting and implementing economic and technical cooperation among themselves, and reiterating the need for the international community to

support the efforts of the developing countries to expand South-South cooperation through the modality of economic and technical cooperation among developing countries,

<u>Taking note</u> of the decisions and recommendations contained in the Final Document of the Eleventh Conference of Heads of State or Government of the Non-Aligned Countries, held at Cartagena de Indias, Colombia, in October 1995, and in this context welcoming the operationalization of the Non-Aligned Movement Centre for South-South Technical Cooperation, in Jakarta in 1998, and inviting all development partners to make use of and give support to the Centre,

Taking note also of the Declaration adopted by the Ministers for Foreign Affairs of the Group of 77 at their twenty-first annual meeting, held in New York on 26 September 1997, in which the Ministers emphasized the increasing importance and complementarity of economic and technical cooperation among developing countries as a means of supporting and broadening the global partnership in international development cooperation,

Welcoming the Declaration and Plan of Action adopted by the South-South Conference on Trade, Finance and Investment, held at San José, Costa Rica, from 15 to 19 January 1997, which outlined concrete modalities on sectoral issues relating to trade, finance, investment and enterprise cooperation,

Welcoming further the outcome of the Asia-Africa Forum II, held at Bangkok in June 1997, as a mechanism to strengthen South-South cooperation, as well as the convening of the Second Tokyo International Conference on African Development in October 1998, and calling upon the international community to reaffirm its commitment in supporting Africa's development efforts;

- 1. <u>Endorses</u> the report of the High-level Committee on the Review of Technical Cooperation among Developing Countries on its tenth session³ and the decisions adopted by the High-level Committee at that session;⁴
- 2. <u>Takes note</u> of the report of the Secretary-General on the state of South-South cooperation, but which provides a comprehensive and systematic overview and analysis of economic cooperation among developing countries in the context of South-South cooperation worldwide and of United Nations system support for such cooperation;

- 3. Takes note also of the draft revised Guidelines for the Review of Policies and Procedures concerning Technical Cooperation among Developing Countries, submitted by the Administrative Committee on Coordination, and recommends that the draft revised Guidelines be submitted through the Economic and Social Council to the General Assembly at its fifty-third session in the context of the triennial policy review of operational activities for development of the United Nations system;
- 4. <u>Invites</u> the United Nations Conference on Trade and Development and the Special Unit for Technical Cooperation among Developing Countries of the United Nations Development Programme, as well as other relevant organizations, to jointly undertake further work on formulating concrete recommendations on the follow-up and implementation of the Declaration and Plan of Action adopted by the South-South Conference on Trade, Finance and Investment;
- 5. <u>Decides</u> to intensify the process of strengthening the various interregional dialogues and the exchange of experiences among subregional and regional economic groupings for the purposes of expanding South-South cooperation through integrating the modalities of economic and technical cooperation among developing countries;
- 6. <u>Calls upon</u> all Governments and relevant United Nations organizations, including the multilateral financial institutions, to consider increasing allocations of resources for economic and technical cooperation among developing countries and to identify and support innovative funding modalities to promote South-South cooperation, such as triangular cooperation and private sector funding;
- 7. <u>Welcomes</u> the contribution made by some countries to the Voluntary Trust Fund for the Promotion of South-South Cooperation, and invites all countries, especially developed countries, to contribute generously to the Trust Fund;
- 8. <u>Urges</u> all parties in the development cooperation to make concerted, coordinated and vigorous efforts towards mainstreaming the modalities of economic and technical cooperation among developing countries in their operational activities by providing full support in the design, formulation, implementation and evaluation of programmes and projects;
- 9. <u>Decides</u> to hold a commemorative meeting during the fifty-third session of the General Assembly to mark the twentieth anniversary of the adoption of the Buenos Aires Plan of Action for Promoting and Implementing Technical Cooperation among Developing Countries, ⁶ and to this end requests the Special Unit for Technical Cooperation among Developing Countries, in its capacity as substantive secretariat of the High-level Committee on the Review of Technical Cooperation among Developing Countries as well as system-wide coordinator on technical cooperation among developing countries, to be responsible for the preparation

and organization of the commemorative meeting, in consultation with the Member States and relevant organizations and agencies of the United Nations system;

- 10. Also requests the Special Unit for Technical Cooperation among Developing Countries, in consultation with the Member States and relevant organizations and agencies of the United Nations system, to prepare and submit, through the Economic and Social Council for consideration by the General Assembly at its fifty-third session, a comprehensive assessment of the progress made in the implementation of the Buenos Aires Plan of Action and its impact since its adoption, as well as recommendations for the broadening of the global partnership in international development cooperation and strengthening the integration of the modalities of economic and technical cooperation among developing countries, in the context of the triennial policy review of operational activities for development of the United Nations system;
- 11. <u>Requests</u> the Secretary-General to report to the General Assembly at its fifty-third session, in the context of the triennial policy review of operational activities for development of the United Nations system, on the implementation of the present resolution;
- 12. <u>Decides</u> to include in the provisional agenda of its fifty-fourth session the sub-item entitled "Economic and technical cooperation among developing countries".
